NewGen Administrative Services, LLC ("NewGen") is committed to protecting the privacy and security of the information of patients and employees of the facilities it serves. On February 23, 2024, we began mailing notification letters to certain individuals whose information may have been involved in the data security incident that occurred at M-Theory, a third-party service provider that hosted two (2) servers containing some of our data.

On or about September 14, 2023, M-Theory notified us that on September 13, 2023, it had determined that a security incident occurred. Unfortunately, despite our best efforts, we have not been able to confirm what, if any, information stored on these servers was accessed or acquired without authorization. Therefore, out of an abundance of caution, we are providing notice to all individuals whose information may have resided on the impacted servers and, thus, may be impacted by this event.

NewGen determined that the impacted servers contained personal health information belonging to certain individuals. The information varies per individual but may have included some or all of the following; name, diagnosis/conditions, lab results, medications, other treatment information, address, date of birth, driver's license and/or state identification number, Social Security number, other identifiers, claims information, credit card number, bank account number, and other financial information.

While we have no evidence that individual's information has been misused for the purpose of committing fraud or identity theft, individuals whose information may have been involved are encouraged to review the notification they receive, including guidance on what they can do to protect themselves, should they feel it appropriate to do so.

We value individual's privacy and deeply regret any concern this may cause. We are taking all steps necessary to respond to this incident. To help prevent something like this from happening again, NewGen is completing a comprehensive technology evaluation and implementing stronger security measures.

This notice is being provided by NewGen, registered as NewGen Administrative Services, LLC, in its capacity as a business associate to multiple covered entities and in accordance with media notice requirements of the Health Insurance Portability and Accountability Act (HIPAA), as amended by the Health Information Technology for Economic and Clinical Health (HITECH) Act. NewGen has notified impacted individuals and relevant regulatory bodies, including the U.S. Department of Health and Human Services (HHS).

STEPS YOU CAN TAKE TO PROTECT PERSONAL INFORMATION

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a

consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
